
Promotion Regulation – “March 2026 Free Delivery – Slovakia”

Organizer

The organizer of this promotion is SOLARKIT Europe Ltd, operating the B2B webshop at shop.solar-kit.eu.

1. Promotion Period

The promotion is valid only for webshop orders placed and completed between **5 March 2026** (00:00 CET) and **31 March 2026** (23:59 CET). Orders placed outside this period are not eligible.

2. Eligible Participants

The promotion is open exclusively to B2B customers of SOLARKIT Europe Ltd with:

- An active webshop account registered in **Slovakia**, and
- A valid Slovakian company registration and delivery address.

Participation is limited to **two (2) eligible orders per customer account during March 2026**.

3. Promotion Benefit

Eligible customers receive free delivery on qualifying webshop orders.

Free delivery applies only to shipments dispatched from the **Budapest warehouse**.

4. How to Apply the Free Delivery

To receive free delivery, the customer must enter the following coupon code **on the cart page (before proceeding to checkout)**.

If the coupon code is not applied on the cart page, free delivery cannot be granted retroactively.

5. Qualifying Conditions

An order qualifies for free delivery if all of the following conditions are met:

- The order is placed via the SOLARKIT B2B webshop only (non-webshop orders are not eligible).
- The minimum net order value is 5,000 EUR (excluding VAT and excluding shipping costs).
- The order contains only products that are:
 - In stock at the time of order placement, and
 - Available from the Budapest warehouse.
- The order is shipped within March 2026.
- The order is not cancelled, returned, or unpaid.
- The coupon code is correctly applied **on the cart page** before checkout.

If any of the above conditions are not fulfilled, standard delivery charges apply.

6. Exclusions

The promotion does not apply to:

- Solar panel (PV module) products.
- Products shipped from warehouses other than Budapest.
- Mounting rails exceeding 2,4m
- Backorder or pre-order items.
- Partially fulfilled orders where part of the shipment does not meet the eligibility criteria.

Solar panel products are explicitly excluded from this promotion, even if all other conditions are fulfilled.

7. Abuse and Verification

The organizer reserves the right to:

- Verify stock availability and warehouse origin.
- Cancel the free delivery benefit in case of abuse, manipulation, or violation of these rules.

- Apply standard shipping fees retrospectively if conditions are not met.

8. Changes and Termination

The organizer reserves the right to modify, suspend, or terminate the promotion at any time for justified reasons, while safeguarding participants' rights already acquired.

9. Acceptance of Terms

By participating in this promotion, the customer accepts these Promotion Rules in full.
